The River of Hope

WHEN HUNDREDS OF thousands of Gaza's civilians headed north after the latest ceasefire, the word most commonly used by the few brave Palestinian journalists who had escaped Israeli assassination to describe the mood was one of Hope. Not that they hoped to find their homes intact or even partially standing; not that they hoped it would be easy or even possible to dig out the bodies of loved ones from under the rubble. It was a more generalised hope that they

would, at last and at least, no longer live under the daily (more often, nightly) threats of death, and that, in some way, life would become a bit more liveable.

We witnessed on our screens the devastation caused by the Israeli forces (IDF) to the fabric of civilian existence in Gaza, but most of our media failed to report on the most horrific tactic. This was the development of what were known as "boobytrapped robots", in which out-

of-date armoured personnel carriers (APCs) were packed with explosives and operated remotely. These were sent in to residential neighbourhoods where they would typically explode early in the morning, causing maximum panic. Or else, they would lay a trail of explosives to be ignited at once. (This was reported in the Israeli press and by critical online monitors such as *Middle East Eye*, but I only heard it mentioned once – by the excellent Jeremy Bowen – on the BBC). First used last year, this tactic became widespread in the renewed offensive before the ceasefire with the clear aim of making huge swathes of Gaza uninhabitable.

Yet Gaza is being re-inhabited – at least the half of the territory from which at the time of writing the IDF has been withdrawn. In such dire conditions, one may ask, how is it possible to maintain even the slightest vestige of "hope"? One answer to this is specific to the existential experience of the Palestine people for whom dispossession has been woven into the history of their last three quarters of a century. The passionate resolve of so many Gazans to return to this devastated wasteland, expressed in many interviews, reflects in part a resolve not

to submit to permanent exile – another *nakba* comparable to that of 1948. (There are others who would prefer to leave, but there is no evidence of a mass demand, apart from the more limited effort to take the badly wounded, especially children, to medical facilities abroad).

Beyond this, hope seems to be a widespread human mechanism to sustain existence in the worst of circumstances – indeed, without a measure of hope (at times even optimism) for

> the future, humanity might simply have ground to a halt long ago. Reflecting on this, I have come across several expressions of hope which I would like to share. The first is from Auschwitz: the survivor Primo Levi wrote that although hope was not a sufficient condition for staying alive (having a skill that the Germans might employ was the main requirement), complete despair could be avoided through hope, because of one's "imperfect



knowledge of the future".

My second example comes from Drapchi prison in Tibet, where groups of Buddhist nuns in the late '80s to '90s were imprisoned and tortured for daring to voice publicly their support for the Dalai Lama and independence. In defiance, they composed a set of songs that were smuggled abroad and led to more punishment. One of the poems ends with these lines:

A time will come when the sun will emerge / From the cloud and shine clearly. / Our hearts are not sad; Why should we be sad? Even if the sun doesn't shine during the day / There will be the moon at night.

My last example comes from Hiroshima, in a poem by Kurihara Sadako who was a survivor and become known as the "poet of Hiroshima". Her poems were never fierce or angry, and her poem "River's rebirth", written in 1966, is a poem of hope.

Rain falls on the ruined city... / and plants regain their colour and freshness. / The river mirrors the blue sky / and heals wounds.

The river of hope flows without end.

Britain's nuclear hypocrisy

FRIDAY 26 SEPTEMBER marked the International Day for the Total Elimination of Nuclear-Weapons. On this day CND launched the campaign against Britain's reckless nuclear expansion, starting with a legal opinion we have secured showing that the government's expansion of its nuclear weapons capability is in clear breach of international law.

The new legal opinion, finds that Britain's purchase of 12 F-35A nuclear-capable fighter jets is in violation of its commitments under Article VI of the nuclear Non-Proliferation Treaty (NPT). This article states: that, '[e]ach of the Parties to the Treaty undertakes to pursue negotiations in good faith on effective measures relating to cessation of the nuclear arms race at an early date and to nuclear disarmament, and on a treaty on general and complete disarmament under strict and effective international control.'

In their joint opinion, international law experts Professor Christine Chinkin and Dr Louise Arimatsu, argue: "[t]he decision of the UK to purchase F-35a fighter jets rather than any other model is precisely because the aircraft can 'deliver both conventional and nuclear weapons' and thereby enable the RAF to reacquire 'a nuclear role for the first time since 1998.' Reinstating a nuclear role for the RAF represents a reversal of the UK's long-term commitment to nuclear disarmament, including under the NPT."

This expansion is, in the words of the Starmer government the 'biggest strengthening of the UK's nuclear posture in a generation'.

This is yet another breach of the NPT by a British government. Back in 2005 a legal opinion found that replacing Trident would put Britain in material breach of the NPT. Many viewed Britain's decision in 2021 to increase in its nuclear warheads by 40% also in breach. There are also serious concerns that the Aukus Treaty – which facilitates nuclear-sharing between the US, Britain and Australia – also breaches the NPT. Ensuring that Australia will become the first non-nuclear weapons state to be able to deploy nuclear-powered submarines will certainly constitute nuclear proliferation.

It is not just CND that have been questioning the legal basis of this nuclear expansion. MPs and peers have been doing the same. Britain's breach of its international disarmament obligations under mine the case for global nuclear disarmament and nuclear non-proliferation. The British F35A fighter jets will be part of a NATO mission. NATO, the most powerful nuclear-armed alliance in the world, has a first-use nuclear strike policy. This means it is an aggressive, not a defensive alliance. These dual-capability jets can launch B61-12 nuclear bombs, which have been designed by the US specifically to be used in war.

The legal opinion is also very important in drawing attention to Britain's nuclear hypocrisy, and the impact this is having on driving nuclear tensions. As both Arimatsu and Chinkin state in their final reflections 'we consider the hypocrisy that allows it [the British government] to pursue its own modernised nuclear policy while asserting the unsuitability of other states to pursue theirs to be indicative of double standards and a defence policy lacking in morality.'

The day CND published this legal opinion exposing the British government's clear breach of its disarmament obligations, the UK ambassador Barbara Woodward, was at the UN arguing that "Iran is defying the global non-proliferation regime" and voted to ensure sanctions are reinstated on that country.

This was despite the fact that Iran – after US and Israeli illegal bombing of its nuclear facilities – had reached an agreement with the International Atomic Energy Agency (IAEA) that inspectors could return to conduct on-site inspections of its facilities. Sanctions may well now undermine this agreement.

Britain's Strategic Defence Review reasserts that British nuclear weapons should be used to stop other countries' nuclear proliferation. It specifically refers to the right of Britain – as part of NATO – to launch a nuclear attack against a non-nuclear weapons state that is a signatory to the NPT that is in 'material breach of those non-proliferation-obligations'. In this current situation, how will Iran interpret such nuclear threats?

It is clear that Britain's nuclear hypocrisy and its dangerous expansion have nothing to do with making the British population – or the world – safer. So long as nuclear weapons states like Britain continue to re-arm and threaten to use their nuclear weapons against non-nuclear weapons states, the threat of nuclear proliferation and of nuclear weapons being used again in war will increase. ■

Trump announces resumption of nuclear testing

On October 30, President Trump ordered the US military to immediately resume the process for testing nuclear weapons. If this proceeds according to his order, the testing (detonating) of nuclear weapons will end a 33 year-long U.S. moratorium on nuclear testing and this would be extremely dangerous for humanity. If Trump is referring to the resumption of explosive nuclear testing, this would be an extremely unfortunate, and regrettable, step by the United States.

It would almost inevitably be followed by tit-fortat reciprocal announcements by other nuclear-armed states, particularly Russia and China, and cement an accelerating arms race that puts us all in great jeopardy. It would also create profound risks of radioactive fallout globally. Even if such nuclear tests are conducted underground, this poses a risk in terms of the possible release and venting of radioactive materials, as well as the potential leakage into groundwater.

The Comprehensive Nuclear Test Ban Treaty has been signed by 187 countries – it's one of the most widely supported disarmament treaties in the world.

The US signed the treaty decades ago, but has yet to ratify it. Nonetheless, it is actually legally bound not to violate the spirit and purpose of the treaty while it's a signatory.

Nuclear watchdogs worldwide are wondering what might come of Trump's pronouncement — and what he even means since the US hasn't

conducted a nuclear weapons test in decades. "First of all, every statement in that post is wrong," said Matthew Bunn, a nuclear weapons expert at Harvard University. "It's not true the United States has the world's most nuclear weapons. It's not true that other states are carrying out nuclear tests. (Trump) seems to think it's the Department of Defense that carries out nuclear tests. It's not. It's the Department of Energy."

Trump's own nominee to head the US Strategic Command seemed unclear of the president's intent as he faced the Senate Armed Service Committee in a confirmation hearing, "Neither China nor Russia has conducted a nuclear explosive test," Navy Vice Adm. Richard Correll said, "so I'm not reading anything into it or reading anything out." The Center for Arms Control and Non-Proliferation defines nuclear tests as "generally controlled explosions of nuclear devise, such as bombs or warheads," and Russia's missile and torpedo tests do not meet that strict definition. What's more, Jon Wolfsthal, who advised both Joe Biden and Barack Obama on nuclear matters, notes other nations are already conducting similar tests – along with the US. "Russia, the United States, China are all investing tens of billions of dollars on new nuclear delivery platforms - missiles, bombers, submarines," Wolfsthal said. "We have returned to the arms race dynamics of the Cold War where each side believes nuclear weapons are important."

Labour's Fifth Column

I'VE NEVER SEEN so many people turn up for a half-hour script in hand performance as the crowd who filled the Main Hall at the Centre, for Pete Cann's production of his new play, **Labour's Fifth Column**. No doubt there were plenty of card-carrying members but there were plenty of others too.

Set in 1960 when division racked the Labour Party over nuclear weapons, **Labour's Fifth Column** blows the lid off the secrecy and lies that prevailed, most notably relating to funding from the CIA.

The cast of seven men – excluding Deb Puleston as the Narrator – played ten roles, led by Gerard Ward as Hugh Gaitskell, Leader of the Opposition to Harold Macmillan's Conservative Government. In their dark suits with the occasional bow tie reminiscent of the broadcaster Robin Day, they reinvented some memorable politicians amid growing unrest. I confess to wishing Stewart Ravenhall as Jo Hodson, the American interloper, had worn a ten-gallon hat rather than a trilby, but

you can't have everything. My only real grouse was that in a half-hour play on a set with no obvious wings it was hard to get my head around the doubling. Unsure about the title too.

The screen was used to great effect, displaying among other things, a vintage Labour party liberty badge and finally – in almost total silence – Hiroshima. Thanks to Steve Cooney who also operated powerful sound effects including The Red Flag and the national anthem.

The Q and A that followed continued to astonish. Few had left their seats when Pete came forward to introduce his special guests.

Stephen Marks, to whom the play is dedicated and who was expelled from the Labour Party after more than forty years, responded to questions and gave us more insight, ably assisted by Nigel Day, of Oxford CND.

Finally, reluctantly, the crowd dispersed. ■

Nuclear sink hole

THE GOVERNMENT DEPARTMENT for Security and Net Zero's annual expenditure? Not least as the details of this (on p.18 of its 2024-2025 Annual Report & Accounts) are completely mindblowing. To summarise: Total departmental spend: £8.6 billion; Total spend on nuclear power: £5.1 billion (60%); Total spend on everything else: £3.5 billion (40%) See what I mean? Literally mindblowing! A few more details on the nuclear side of things: Nuclear Decommissioning Authority: £3 billion (dealing with the legacy of past nuclear programmes).

Support for Sizewell C power station: £1.67 billion. UK Atomic Energy Agency (UKAEA): £400 million (doing bonkers stuff like nuclear fusion). Managing our 'Energy Legacy': £85 million (roughly half the total figure). Great British Nuclear: £26 million (the more or less useless quango overseeing this fiasco).

That's the size of the nuclear sink hole: roughly £5.1 billion! Leaving roughly £3.5 billion for everything else, including all direct support for renewables, 'delivering affordable energy', science,



research and 'capability', as well as other arm's length bodies. Moreover, even that low figure is not quite what it seems: roughly £450 million is set aside for another of Ed Miliband's sink holes, namely Carbon Capture and Storage.
